Wedding Package | Details

All Packages Include

- Access to the course for photos
- Access to the A/V system
- Black or white table linens and colored linen napkins
- Buffet Meal* with beverage station (water, tea, and coffee)

 - (This will be on a case-by-case basis)
- Table set up and tear down by AP staff
- 5-hour room rental

1. Ceremony and Reception

This all-inclusive package starts at **\$45.00 per person**. This package includes:

- Patio ceremony
- Ceremony chairs
- One-hour access to the patio the night before for rehearsal
- Upgrade your ceremony to "on the course" for an additional **\$750.00**
 - (This option is available from May-August)

2. Reception Only

This all-inclusive package starts at **\$38.00 per person**.

*Buffet Meal

- **Traditional:** Tossed garden salad, brisket, grilled chicken, garlic mashed potatoes, green beans, and dinner rolls
- **Italian:** Caesar salad, lasagna, grilled chicken alfredo, green beans, and breadsticks
- **BBQ:** Tossed garden salad, pulled pork, pulled chicken, baked potato casserole, baked beans, and buns for sandwiches



Outside Catering

Groups of 79 or less - **\$300.00**

Groups of 80 or more - **\$500.00**

- Your caterer must be self-sufficient.
- Adams Pointe does not permit the usage of our kitchen for banquet events.
- The booking party must provide all dining supplies (i.e., plates, cups, silverware, service ware, etc.)



Partial Catering Service

Adams Pointe can provide partial service for your event.

This service is for those parties wishing to bring their food but would like it served by Adams Pointe staff.

Groups of 79 or less - **\$400.00**

Groups of 80 or more - **\$600.00**

This fee includes:

- Black or white table linens and colored linen napkins
- All buffets are prepared on-site and include plates, silverware, glassware, chafers, service ware, and staff for full buffet service
- Adams Pointe staff will clear dinnerware

Wedding | Policy Of Use

Important Points of Interest

A **\$500.00** deposit is required to hold the event space and date. Once this contract has been signed and returned along with payment of the deposit, Adams Pointe will consider your event confirmed and definite. Event deposits are non-refundable in the event of a cancellation by the event sponsor. The client is responsible for the final appearance of the patio and clubhouse. Any out-of-ordinary damage caused by the client or guests will be the responsibility of the client. AP representatives have the final say on determining the final appearance of the clubhouse. Examples of damage are unnecessary icing on carpet, windows, walls, etc. Restrooms left in complete disarray. All physical damage done to any part of the venue (inside or out). If an AP representative feels that the venue is left in a condition of damage then we will retain **\$350** from the original deposit. Any physical damage that is greater than **\$350** will be assessed by the GM and invoiced at a later date. All items of concern will be photographed. All children under 12 must be supervised by an adult when outside the banquet room. This includes hallways, lobby area, players grille, restrooms, and patio. The client acknowledges that the property has hazards, including golf carts, stairs, and ponds. Decorations not permitted by AP are helium balloons, glitter, gel products, water beads, and items that can damage the event space. Artificial petals, confetti, rice, or any "biodegradable" items may not be used during ceremonies. We will allow real flower petals, bubbles, or birdseed.

Banquet Policies

Responsible Alcohol Management Policy

Adams Pointe Golf Club is the sole licensed authority to sell and serve alcoholic beverages for consumption on the premises. All alcoholic beverages are to be supplied by the golf course and absolutely no alcoholic beverages can be allowed in the building unless purchased at the facility. All alcoholic beverages served under our licenses will require the Adams Pointe employees to dispense them. Per Missouri State Law, Adams Pointe employees will request proper identification for any person of questionable age. Without exception, we refuse the service of any alcoholic beverages to anyone less than 21 years of age. The management and staff may also refuse to continue serving anyone we feel has already consumed their limit of alcohol. Minors are the responsibility of the booking party. Possession of alcohol by a minor will result in an immediate action to remove the parties involved up to and potentially including, the termination of the entire event without refund.

Buffet Service Policy

Per Jackson County Environmental Health code, we must decline carry-out containers during or after the buffet service. Buffet service will remain available to your guests for 1.5 hours. Some exceptions may apply.

Damage or Loss

Adams Pointe Golf Club does not assume any responsibility for damage to, or loss of, any personal articles or merchandise left on its premises before, during, or following the function. The banquet party assumes responsibility for any damages to the facility, property, and furnishings incurred by any guests before, during, or after the function. Damage charges may be assessed to parties unable to reasonably comply with the aforementioned statement; subject to Food & Beverage Manager's discretion.

Liabilities

In consideration of its use of Adams Pointe's facilities for the event, for itself, its successors or assigns, or its heirs, executors and administrators, the Organization releases and forever discharges the City of Blue Springs, Orion Management Solutions, Adams Pointe Golf Club, their successors and assigns, and all of their members, managers, parent and affiliated companies, directors, officers, employees and agents and their heirs, executors and administrators, from any and all manner of claims demands, damages, causes of action, suits or liability, known or unknown, fixed or contingent, on account of injury or loss to the organization, its representative in this present contract, and its members and its quest attending the event allegedly sustained or received by the organization, or that might subsequently accrue to any one of all of them by reason of any matter or thing whatsoever, and particularly growing out of or in any way connected with the organization's use of Adams Pointe's facilities for the event or for any preparations for the event on Adams Pointe's premises.
